The following By-law Amendment to be discussed at the February 2017 Membership Meeting, and will be voted on at the at the March 2017 Membership Meeting

Article VI - Organization, Section 9H

Current By-Law:

(The President shall) appoint and serve as Chair of the Roma Lodge/RIWA Advisory Committee which monitors and makes recommendations on RIWA operations to the Board of Directors.

Proposed Amendment:

(The President shall) appoint and serve as Chair of an advisory committee to the Board of Directors concerning the Roma Lodge business known as the Racine Italian Welfare Association. (The committee will be known as the "RIWA Advisory Committee" and the business will be referred to herein as the "RIWA".) The RIWA is responsible for operation of the Roma Lodge banquet halls which are open to the public and the Roma Lodge Members' Lounge (both bar and restaurant). The RIWA Advisory Committee shall monitor and make recommendations to the Board of Directors regarding general operations and procedures of the RIWA.

- 1. The RIWA Advisory Committee shall:
 - a. Consist of the President, the General Manager of the RIWA and at least 3, but not more than 5, other members. Committee members are appointed by the president with approval of the Board of Directors.
 - b. Monitor the financial and overall operational aspects of the RIWA business and make recommendations to the Board of Directors concerning RIWA operations,

- c. Ensure that the RIWA organization has a clear mission, that the mission is carried out, and that the mission is promoted widely throughout Roma Lodge and the community
- d. Conduct mandatory quarterly meetings, or more often as conditions dictate,
- e. Make recommendations to the Board, as necessary, to assure that a General Manager for the RIWA is in place to autonomously manage the day to day operations of the banquet halls and Members' Lounge,
- f. By November 1st of each year, submit for approval by the Board of Directors an annual operating budget for the RIWA to be prepared by the General Manager in consultation with, and advice from, the RIWA Committee

ROMA LODGE MERIT SCHOLARSHIPS

What is the Scholarship?

Each year Roma Lodge makes scholarships available to children of its members. There is a \$4,000 scholarship, payable in \$1000 increments at the beginning of each of four academic years. In addition, the Lodge awards a maximum of three one-time \$500 scholarships to the second, third, and fourth place rated scholarship applicants. The scholarships can be applied to any full time course of study leading to a recognized baccalaureate degree at any accredited United States college or university of the recipient's choice.

Who is Eligible?

All graduating high school seniors, who are biological or adopted children of Roma Lodge members, are eligible to apply for the scholarship. An applicant's father must be a member in good standing as of January 31st of the calendar year that application for the scholarship is made. A scholarship recipient's father must continue to be a member in good standing for the duration of the scholarship. Candidates must be planning to pursue a full-time program of study (12 credits or more) in a college or university in the United States. Recipients of the Roma Lodge Merit Scholarships will not receive any other scholarships offered through Roma Lodge.

Application Requirements

The applicants must:

- Complete a high school college preparatory course of study
- Demonstrate a commendable academic record which will qualify for admission to the college or university of their choice.
- Demonstrate positive citizenship and leadership qualities through participation in school and community activities.
- Show potential for higher academic success by achieving ACT or SAT scores acceptable to the college or university of their choice.
- Submit an official high school transcript
- Submit an ACT or SAT scores report form
- Submit two letters of recommendation

Financial need will not be considered during the selection process.



THE JOHN AND VLASTA KROES MERIT SCHOLARSHIP

What is the Scholarship?

The John and Vlasta Kroes Merit Scholarship was created in 2015 and is funded by Michael Kroes, a member of Roma Lodge, in memory of his parents. The scholarship awards \$1000 to a child of a Roma Lodge member. The scholarship can be applied to any course of study leading to a recognized baccalaureate degree at any accredited United States college or university of the recipient's choice.

Who is Eliqible?

All graduating high school seniors, who are biological or adopted children of Roma Lodge members, are eligible to apply for the scholarship. An applicant's father must be a member in good standing as of January 31st of the calendar year that application for the scholarship is made. A scholarship recipient's father must continue to be a member in good standing for the duration of the scholarship. Applicants must be planning to pursue a full-time program of study (12 credits or more) in a college or university in the United States. Recipients of the Kroes Scholarship will not receive any other scholarships offered through Roma Lodge.

Application Requirements

An applicant must:

- Have maintained, at least, a cumulative 3.0 GPA (on a 4.0 scale) during his/her high school career and through the first semester of his/her high school senior year.
- Complete a high school college preparatory course of study
- Demonstrate a commendable academic record which will qualify for admission to the college or university of their choice
- Demonstrate positive citizenship and leadership qualities through participation in school and community activities.
- Show potential for higher academic success by achieving ACT or SAT scores acceptable to the college or university of their choice.
- Submit an official high school transcript
- Submit an ACT or SAT scores report form
- Submit two letters of recommendation

Financial need will not be considered during the selection process.



THE RUSSELL AND HELEN MISSURELI SCHOLARSHIP

<u>What is the Scholarship</u>: The Russell and Helen Missureli Scholarship was created to recognize their service, over many years, to Roma Lodge, the church, and the community at large. Scholarship funds were donated by the family and friends of the Missurelis on the occasion of Russell 's ninetieth birthday. The scholarship awards \$1000 to a child of a Roma Lodge member.

Who is Eligible?: All graduating high school seniors, who are biological or adopted children of Roma Lodge members, are eligible to apply for the scholarship. An applicant's father must be a member in good standing as of January 31st of the calendar year that application for the scholarship is made. A scholarship recipient's father must continue to be a member in good standing for the duration of the scholarship. Applicants must be planning to pursue a full or part-time program in an associate degree or baccalaureate degree program at any accredited college or university in the United States. Recipients of the Missureli Scholarship will not receive any other scholarships offered through Roma Lodge.

Application Requirements: Applicants must demonstrate:

- Acceptance as a student in an associate degree or baccalaureate degree program.
- An exemplary record of community service as evidenced by a list of community, school, or church related activities.
- Academic achievement as evidenced by a full transcript of grades.
- Good character as evidenced by two letters of recommendation

Financial need will not be considered during the selection process.
